**INFORMATIVE MOTION REGARDING THE CLOSING DATE**

To the Honorable United States District Judge Laura Taylor Swain:

The Government Development Bank for Puerto Rico (“**GDB**”) and the Puerto Rico Fiscal Agency and Financial Advisory Authority (“**AAFAF**”), through their undersigned counsel, hereby state as follows:

1. On November 7, 2018, this Court approved the Qualifying Modification for GDB and entered the *Findings of Fact, Conclusions of Law, and Order Approving Qualifying Modification for the Government Development Bank for Puerto Rico, Pursuant to Section 601(m)(1)(D) of the Puerto Rico Oversight, Management, and Economic Stability Act* [ECF No. 270] (the “**Approval Order**”).<sup>1</sup>

2. On November 9, 2018, the Court entered an order instructing the Clerk of Court to close the above-captioned case on November 19, 2018, absent any timely objections.

3. On November 15, 2018, GDB and AAFAF filed the *Response of GDB and AAFAF to the Order Regarding Closure of the Case* [ECF No. 274] (the “**Response**”). In the Response, GDB and AAFAF requested that the Court keep the case open until the Closing Date. GDB and AAFAF agreed to file an informative motion on or before November 29, 2018 to notify the Court that the Closing Date had occurred and, if the Closing Date had not occurred, to provide a status update with an anticipated Closing Date.

4. On November 16, 2018, the Court issued an order stating that the Court would await the filing of the informative motion described in the Response before closing the case [ECF No. 275].

5. The Closing Date occurred today, November 29, 2018. Accordingly, GDB and AAFAF respectfully request that the Court close the case at its earliest convenience.
