holders of the bonds (the "Bonds"), issued by GDB pursuant to the indenture, dated February 17, 2006, as supplemented, by and between GDB and Wilmington Trust, National

Association, as successor trustee (the "Trustee"), as follows:

GDB makes reference to previous notices posted to EMMA regarding GDB's debt service

payments and the restrictions governing such payments that were implemented by Executive

Order No. OE-2016-014, signed by the Governor of Puerto Rico on April 30, 2016 (the "Executive

Order"). On July 3, 2017, the Trustee was scheduled to make payments in the aggregate amount

of \$9,873,347.29 of interest on certain of the Bonds. Notice is hereby given that, in accordance with the provisions of such Executive Order, such payment on the Bonds has not been made by

GDB.
